

Privacy policy - WEB-SET Interactive GmbH

PLEASE READ THIS AGREEMENT CAREFULLY, AS IT CONTAINS IMPORTANT INFORMATION

WEB-SET complies with the Swiss Law and European Law regarding the collection, use, and retention of data. We will respond to your request for access to modify or delete your information within thirty (30) days.

Other than as described in this Policy, we will not give any information about you to others without your express permission.

To whom does the Privacy Policy apply?

WEB-SET interactive GmbH is a Swiss company, called ("WEB-SET"), provides Internet related services including future ancillary products, services or enhancements, (the "Services"), through our Web Site located at www.WEB-SET.com ("Site") . It is important to WEB-SET that all persons who utilize the Site and our Services understand what information we collect and how we use it. WEB-SET is committed to protecting your privacy in accordance with the terms of this Privacy Policy. Questions regarding this Privacy Policy should be directed to partners@WEB-SET.com. Please read on for further details.

What information do we collect as a registrar from customers of the Service or users of the Site? How do we use "cookies"? How do we use the information we collect?

When you use our Services, WEB-SET asks for customer information including first and last name, organization, street address, city, state, zip code (or country and postal code for non-U.S. residents), telephone number, e-mail address, fax (if available) and credit card information. We also ask for similar information for the billing contact, administrative contact and technical contact for a domain name. We may use this personally identifiable information to contact you, your partners, or your customers (collectively "you") about your account or other matters relating to the Services, such as to inform you about new products or Services that are available through us or on our Site. We may also use this personally identifiable information to send you our newsletter or e-mail messages regarding products or services we think you might be interested in. (See below for instructions on how you can "opt out" of our newsletter or these e-mail messages.) These communications are essential to our relationship with you and to our ability to provide you with quality products and Services that are responsive to your needs. At the same time, these communications, and your responses to them, give us helpful insights about you, your preferences and the ways in which we might improve our Services. We therefore may maintain this information for future use. When you utilize the Services, we may ask you for a "screen name." Although we may not use it now, the screen name you select may appear on the Web site in connection with future Services we provide.

Like many other commercial Web sites, our Site employs a standard technology called a "cookie" to collect information about how our Site or Service is used, such as which pages are the most frequently visited by our customers. "Cookies" are small pieces of electronic information that are stored by your browser on your computer's hard drive. Cookies enable our systems to recognize your browser and provide personalized information and features. If any cookie contains

personally identifiable information, we protect such information with encryption technology. Through the use of cookies, we take note of whether and how you use the Services that we provide, by recording site traffic patterns and maintaining log files of your access to various parts of the Site. We may collect the information passed along by your Web browser that references the Web URL you linked from, the time, type of Web browser being used, screen size, Internet speed of connection, the operating system/platform and CPU speed. This information may be used to identify demographic trends and to provide information tailored to your interests.

Cookies may also be utilized by third parties who advertise or provide links on the Site. Due to the way the Internet technically operates, WEB-SET cannot control the data collection activities by such third-party advertisers or linked Web sites. You should contact these advertisers or Web site operators if you have any questions about their use of the information they collect.

How do you protect my information?

The information we receive from or about you is stored on systems designed to prevent the loss, misuse, unauthorized access, disclosure, alteration or destruction of that information. We also encrypt your transmission of sensitive information to us (e.g., credit card numbers, account passwords) in the interest of heightened privacy protection and information integrity. While we use industry standard security practices, no transmission or storage on the Internet is completely secure.

Will WEB-SET disclose the information it collects to outside parties?

As a registrar of record for domain names, we may make certain information about you or the Registrants of domain names available to the general public via our domain name look-up and directory "WHOIS" service (e.g., name, address, telephone, e-mail and fax (if available) of the Registrant, Administrative Contact, Billing Contact and Technical Contact). Additionally, we may share the information stored on that database, as well as other information we collect or you provide, with our parent and subsidiary companies and other parties selected by us, including with the parties or in the circumstances described below:

1. Agents or vendors who are responsible for handling your Account or performing other necessary services that you or we require.
2. Business partners and vendors whose services you may request or access on or through our Site, or who we believe offer products or services that may be of interest to you.
3. In response to formal requests (e.g., subpoena or court order) made in connection with litigation or arbitration proceedings, or as reasonably necessary to (a) cooperate with law enforcement agencies or otherwise comply with local, state or federal law, (b) enforce or apply the terms of any of our user agreements or (c) protect the rights, property or safety of WEB-SET, our users or others.
4. Transfer of ownership of our business or a part of our business. If our business or a part of our business is acquired, sold or transferred to another business, customer information may be a part of that acquisition, sale or transfer.

How can you opt out of receiving certain e-mail?

In accordance with our Privacy Policy and Service Agreement, we will continue to send you essential communications affecting your account, including, but not limited to, renewal notices, product changes and site outages.

You may not opt out from having you or your customers' personal information displayed in our "WHOIS" database for domain name registrations. We offer a Private Registration service for a fee, however, that will prevent the registrant's contact information from being publicly displayed in WHOIS. Furthermore, some information is not completely removed from our databases because our systems are periodically backed-up.

How do I correct or change Account or Contact Information that I have given to WEB-SET?

WEB-SET uses pixels, or transparent GIF files, to help manage online advertising. These GIF files are provided by our ad management partner, Google, Affilinet, Tradedoubler or Stailamedia. These files enable these advertisers to recognize a unique cookie on your Web browser, which in turn enables us to learn which advertisements bring users to our Web site. The cookie was placed by us, or by another advertiser who works with these advertisers. With both cookies and Spotlight technology, the information that we collect and share is anonymous and not personally identifiable. It does not contain your name, address, telephone number, or email address.
