§1 Loan amount

The loan becomes effective as soon as the amount is paid out to CH87 0900 0000 8557 7254 4 and both parties have given their consent.

§2 Repayment

The borrower undertakes to repay the loan in 36 monthly installments, starting on the 1st of the month following the 30 days after the transfer (*example: If the transfer took place on October 21, then the first installment is due on December 1. During this phase, the projects are identified*).

§3 Interest

The loan amount bears interest at a rate of 15% per annum (rounded), as shown in the table on page 1.

§4 Early repayment

The borrower has the right to repay the loan early in whole or in part. The lender has the right to demand early repayment of the loan, in whole or in part. In the event of such early repayment, the following conditions apply: A deduction of 5% of the remaining loan amount plus a processing fee of CHF 200. Payment will be made within 45 days.

§5 Final provisions

As the amounts are too small for the investment, they are not subject to FINMA supervision or deposit protection. Amendments and supplements to this contract must be made in writing. Should individual provisions of this contract be or become invalid, this shall not affect the validity of the contract as a whole.
